3. Please make sure that the Plagiarism of your final camera ready paper should be below 25%, using standard plagiarism checking software, before submitting the camera ready paper from your end to confirm the inclusion of the paper in IEEE Xplore.
4. The number of pages in Final Camera Ready Paper must be within 06 Pages. Extra 2 Pages will be allowed with Extra Page Charges as mentioned on the conference website.
5. The final manuscript should have the Copyright Clearance Code notice at the bottom of the first page as mentioned below.
